Constrain is a new generation water based insecticide spray with a neutral pH for the control of a wide range of insect pests (wood borers, clothes moths, carpet beetles, spider beetles, biscuit beetles, silverfish & book lice etc.) found in museums, historic houses etc. Constrain has been tested and found to be safe to spray directly onto a wide range of materials and surfaces. However, it is always advisable to test a small amount on an inconspicuous area first.

Directions for use:

Spray steadily approximately 20-30cm from affected area. Application rate: 10-20ml m². Always test on an inconspicuous area first. Repeat treatment regularly.

Application :

Apply by watering or spray.

Apply at a rate of 20 - 50ml per metre square. (1L per 20 - 50 square metres)

Apply by space spray at a rate of 1 - 4ml per metre cube.
